The protection of digital consumers

Brussels, March 15, 2016, 15:30 - 20:00

As part of its Digital Single Market Strategy, the European Commission has launched the most important review of EU regulatory framework for digital services of the last 20 years. Consumer protection is at the core of the debate.

The seminar will look at whether the current rules protecting digital consumers are suited to the evolution of the Internet eco-system and which reforms are needed.

Questions raised at the seminar will be:

- Is there a need for additional protection of the consumers in the digital world? And if yes, what are the reasons?
- Is there a need for different rules for various digital services (telecommunications, audio-visual, ecommerce) or should we move towards a horizontal protection for all digital services?
- Are different national rules sustainable? Should we move towards complete harmonisation rules?
- Are the enforcement mechanisms appropriate? Should all Member States move towards the establishment of a national consumer protection authority?
- Do current rules sufficiently take into account insights from behavioural studies?
