Smart regulation for Access and Interconnection

Brussels, March 25, 2015, 15:30 - 19:30

Electronic communications markets are changing and evolving towards more concentrated markets: the mobile sector is consolidating, mobile-only operators are seeking ways of providing fixed services, more fibre is deployed in the local loop with consequences on the offering of wholesale broadband services.

This edition of the Brussels Internet & Telecom Seminar will address the impact that those market evolutions should have on the economic regulation for access and interconnection. In particular the seminar will discuss whether the Significant Market Power test need to be changed into another test, such as essential facilities, significant lessening of competition as in the Merger Regulation or a bottleneck test. In doing so, our seminar will also feed in the current BEREC discussion on the need to regulate tight oligopoly.

On interconnection, following the application of the pure LRIC concept, voice termination rates are now standing at around 0.1 eurocent for fixed and around 1 eurocent for mobile in most Member States. With such low levels, the question has to be asked whether the costly process of maintaining cost accounting systems is really worth the efforts.

Finally, panelists will share their views on whether the debate on data termination - opened in the run up to the ITU WCIT of Dec 2012 – should be reignited.
